**College Readiness Block Grant**

**ISSUE**

The College Readiness Block Grant (CRBG), authorized by Senate Bill 828, is designed to provide California high school pupils, particularly unduplicated pupils, additional support to increase the number of students that enroll at institutions of higher education. To be eligible for this grant funding LEAs must have at least one unduplicated pupil and be currently accredited, or in the process of obtaining accreditation, from the Western Association of Schools and Colleges. LEAs shall develop a plan describing how funds will increase or improve services for unduplicated pupils and measure the impact of the funds received.

**BACKGROUND/PREVIOUS BOARD ACTIVITY**

This item appeared before the Board as a *Discussion Item* at the regular meeting on January 18, 2017.

**DISCUSSION**

The Lake County Office of Education will receive their apportionment of \$75,000 for high school pupils at Hance by the end of spring 2017. Funds may be expended anytime during the 2016-17, 2017-18 and 2018-19 fiscal years. The funds will support plans outlined in the LCOE LCAP, specifically providing students will opportunities for dual enrollment, chances to visit post-secondary institutions and stipends to pay for appropriate student tests (i.e. PSAT, SAT and ACT).

**FISCAL, STAFFING, AND FACILITIES**

Current classified and certificated staff would assist with implementation of the CRBG.

**SUPERINTENDENT'S RECOMMENDATION**

The County Superintendent of Schools recommends approval of the College Readiness Block Grant.

## College Readiness Block Grant Required Report

The College Readiness Block Grant (CRBG), established by Chapter 29, Statutes of 2016 (Senate Bill 828, Committee on Budget and Fiscal Review), requires (as a condition of receiving funds) local educational agencies (LEAs) to report to the State Superintendent of Public Instruction, by January 1, 2017, on how LEAs will measure the impact of the funds received on their unduplicated pupils' access and successful matriculation to institutions of higher education, as identified within their plan (as required by *Education Code (EC) Section 41580*).

Chapter 29 also requires the California Department of Education (CDE), on or before April 30, 2017, to compile and submit a report to the appropriate policy and fiscal committees of the Legislature on how LEAs will measure the impact of the CRBG funds received. To enable CDE to meet this legislative reporting requirement, and to prevent any delays in the second apportionment of CRBG funds, LEAs must submit the report identified above no later than January 1, 2017.

Lake County Office of Education schools are located in a small, rural county in Northern California. Because of our isolation, few of our COE students are familiar with the post-secondary opportunities available to them throughout our county and Northern California. One way that we will measure our impact is by the number of students that are provided access to site visits at a variety of CCs, UCs and CSUs. We will take small groups of students (10-15 high school students) on at least 3 visits a year to a variety of college sites. We will invite representatives from area colleges to visit our site and we will pay for PSAT and SAT for all appropriate students (estimated at 10 per year).
