Educator Effectiveness Block Grant

ISSUE

The California Budget Act "Educator Effectiveness Block Grant" allocates funds for professional development resources to improve the skills and leadership abilities of California's educators. This one-time allocation presents an opportunity to increase teacher quality and administrator effectiveness. This grant is based on the number of certificated staff for the 2014-15 school year and allocates \$16,132 to the Lake County Office of Education.

As a condition of this grant, LCOE must develop and adopt a plan explained in a public meeting of the county board of education and adopt the plan in a subsequent public meeting. The funds must be expended by June 30, 2018 and a detailed expenditure report is due to CDE on or before July 1, 2018.

Allowable use of funds is outlined in the Funding Distribution chart and consists of the following four professional development purposes:

1. Beginning Teacher/Beginning Administrator Induction Support
2. Professional Development/Coaching for Educators Needing Improvement
3. Professional Development for Teachers & Administrators Aligned with California State Content Standards
4. Training, Mentoring, & Coaching Certificated Staff to Support Effective Teaching & Learning

The Lake County School Districts also received substantial allocations, based on their number of certificated staff. Many of the Superintendents plan to use their Educator Effectiveness funds to contract LCOE services in the areas of technology and coaching.
