CERTIFYING THAT HCD RELOCATABLE BUILDINGS ARE NO LONGER BEING  
USED FOR SCHOOL PURPOSES

**ISSUE**

As per California Education Code 17292(c), the governing board is required to certify that any re-locatable buildings bearing the insignia and approval from the Department of Housing and Community Development (HCD) will no longer be used as school buildings after September 30, 2015.

**PREVIOUS ACTIVITY**

**DISCUSSION**

The County Board of Education, and by extension, the County Office of Education, does not own or lease any HCD re-locatable buildings. Additionally, the County Office of Education does not currently operate any student programs within HCD re-locatable buildings.

**FISCAL, STAFFING AND FACILITIES ISSUES**

**RECOMMENDATION**

The County Superintendent of Schools recommends adopting a resolution prohibiting the use of HCD buildings as school buildings and certifying that HCD buildings will not be utilized for student programs/school buildings after September 30, 2015.

**RESOLUTION OF THE LAKE COUNTY BOARD OF EDUCATION  
CERTIFYING THAT HCD RELOCATABLE BUILDINGS ARE NO  
LONGER BEING USED FOR SCHOOL PURPOSES**

WHEREAS, SB 1324 was enacted into law on September 18, 2006 and requires that commencing September 30, 2015, any Housing and Community Development (HSC) approved relocatables as outlined in Section 17292 of the Education Code be removed from use as a school building; and

WHEREAS, a Resolution must be approved by the Governing Board by October 30, 2015 certifying that any HCD relocatables as outlined in Section 17292 of the Education Code have been removed from use as a school building commencing September 30, 2015;

NOW, THEREFORE BE IT RESOLVED, That the Lake County Board of Education certifies to the state Allocation Board that Lake County Office of Education does not own or operate any HCD relocatable buildings as outlined in Section 17292 of the Education Code. **PASSED AND ADOPTED** this 15th day of April, 2015, at a regular meeting of the Lake County Board of Education.
