I CALL TO ORDER

II APPROVAL OF AGENDA

V. PROGRAM REPORTS

- **A. STATE AND FEDERAL ACCOUNTABILITY** Cynthia Lenners, Deputy Superintendent, presented information on the State and Federal accountability systems. The State focuses on districts and Federal focuses on schools. The State's data focus is on status and change where Federal just looks at status.
- **B. STATEWIDE SYSTEMS OF SUPPORT** Ms. Lenners provided a chart showing the differences between State and Federal accountability as well as outlining Technical Assistance and Support expectations.

VI. ACTION & DISCUSSION

A. DISCUSSION ITEM – REVIEW OF SECOND INTERIM BUDGET REPORT

Denise Shannon, Assistant Director of Business Services presented the Second Interim Budget Report, which covers the period from November 1, 2018 through January 31, 2019, for the Lake County Office of Education. She reported the Budget has a positive ending balance and provided answers to questions by members of the Board.

B. DISCUSSION ITEM – FIRST READING OF BP 1329 – ALCOHOL USE ON LCOE PROPERTY

Superintendent Falkenberg provided information regarding changes to the law allowing alcohol on school sites. Allowing the policy to pass may increase revenue by holding adult-only events and selling alcohol with the proper permits and supervision. It was noted that both Kelseyville Unified and Konocti Unified have added this policy to their board policies. There was a question of which sites should be approved sites included in the policy. Board President Kinsel polled the Board to arrive at a consensus. The Board agreed to include only the Kesey Room at LCOE Main Office in Lakeport as well as the Taylor Observatory in Kelseyville.

C. CERTIFY CORRECTIVE ACTION AUDIT FINDINGS AND RECOMMENDATIONS FOR YEAR ENDED JUNE 30, 2018.

Cynthia Lenners reported the new Independent Study procedures, outlined in the response to CDE, are in place going forward. It was moved by Dr. Cooper, seconded by Ms. Loustalot, to certify the Corrective Action Audit Finding and Recommendations, assuring that corrective procedures have been implemented and will be used in the ensuing years.
