45-Day Budget Revision Review

Laura Sombs, SELPA Budget Analyst review of the 45-Day Budget Revision Plan.

Laura Sombs, SELPA Budget Analyst provided Governance Council with a breakdown of the 45-day revise, aligning the adopted budget to the 2023-24 State Budget. As required by California Education Code 1622 the Lake County Special Education Local Plan Area

(SELPA) Governance Council reviewed and adopted the 2023-24 Draft Budget which was based on

Governor Gavin Newsom's proposed January Budget.

The 2023/24 45-Day Budget revision aligns the Draft Budget with the final State Budget signed by

Governor Gavin Newsom on July 10th, 2023. The revised budget is presented to the Governance Council as an update and to allow them the opportunity to weigh the goals set for the SELPA in the 2023/24 fiscal year with the funding available.

the approval of the 2023-24 SELPA Local Plan by the California Department of Education. Nicole Wells provided a staffing update, expressing challenges with hiring of qualified staff for the positions of Orientation and Mobility Specialist and Adapted Physical Education Teacher.

Governance Council will review and discuss goals and focused support for the 2023-24 school year for the SELPA department and SELPA Director.

- Megan Grant requested continuing conversation and planning in regards to regional programs including Autism. The request by Governance Council is to identify county programming and determine deficits in the Least Restrictive Environment (LRE) continuum of services. Discussion was posed and recommendations were stated with options of the Lake County Office of Education (LCOE) the Educational Services department shift their focus from Professional Development to student support services. Included in the discussion:
  - Identify available space and locations within Lake county school districts. Two of the Superintendents noted there is potential opportunities in their districts.
  - o Staffing of programs was also briefly discussed.
  - Dr. Annous suggested the idea of creating a sub committee focused on regionalized programming.
- Dr. Annous and Governance Council tasked SELPA with identifying Lake County special education programming, review continuum of services and



programs for each district and county wide and requested a report be brought back to the Governance Council for the September 2023 meeting.

- It is requested that SELPA identify deficits in county programming and develop recommendations for Governance Council to consider.
- Governance Council has assigned this task as the SELPA goal for 2023-24.
